PHENOXY PKHS-27 is a nominal 27% NV solution of acid-modified Phenoxy resin in methyl ethyl ketone (MEK). Phenoxy resins (polyhydroxyethers) are tough, ductile, amorphous polymers having excellent thermal stability, adhesive and cohesive strength, and vapor barrier properties. Phenoxy resin may be crosslinked by reacting its pendant hydroxyl groups with isocyanates, melamine resins or phenolic resins. In addition to hydroxyl groups, Phenoxy PKHS-27 also possesses carboxylic acid groups which can be crosslinked with poly(carbodiimides), poly(aziridines), di-epoxides or poly-epoxide agents & resins. Crosslinked phenoxy resin exhibits excellent chemical resistance, toughness, hardness, and adhesion on many substrates including steel, aluminum, glass, carbon fiber and thermoplastics such as polyamides (Nylon) and polyesters (PET, PBT).
