

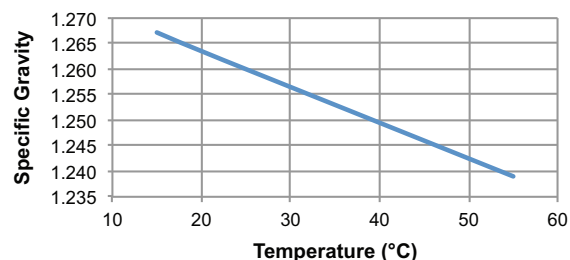
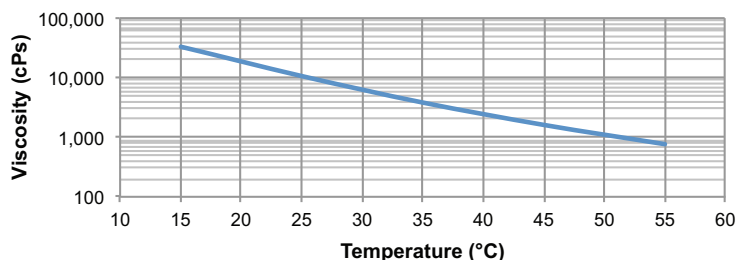

APPLICATION

TEROL 256 is recommended for use in all polyurethane (PUR) systems. The high functionality of TEROL 256 facilitates replacement of a significant amount of polyether polyols in the formulation. Introduction of this polyol in a PUR formulation enhances fire resistance in small scale tests due to the high aromatic content of the polyol, therefore reductions in flame retardant level can be realized.
